Terms and conditions of use

- 1. Strict compliance with the safety regulations must be observed when filming and taking photographs. It must be ensured that visitor operations as well as administrative operations and any possible delivery activities are unimpeded as far as possible. No sources of danger for third parties may be introduced.
- 2. Photographing or filming objects other than those specified in the application, or objects subject to a photography/filming ban, is prohibited.
- 3. The objects may not be touched and may only be moved by authorised employees of the Humboldt Lab. The objects must not be exposed to illumination levels of more than 50 lux extraneous light. The illuminants should not have any UV content. Otherwise, they must be shielded by a UV filter. Only cold-light lamps or lamps with heat protection filters are to be used. The distance between the illuminant and the exhibition object must be at least 1.5 metres. The lamps must be switched off during breaks in shooting as well as during the preparatory and set-up phases.
- 4. Exhibition or event staff may be instructed to supervise the photography or filming team. These or other exhibition staff must be obeyed without fail.
- 5. In the event of any violation of points 1–4, in particular, the Humboldt-Universität zu Berlin or the Humboldt Forum Foundation reserves the right to cancel the photography and filming appointment, to revoke the permission granted, and to expel the team from the Humboldt Lab. The Humboldt-Universität zu Berlin shall decide separately as to how to proceed with photographs and film recordings that have been created up until this point in time.
- 6. The applicant is liable for all damage caused to the Humboldt-Universität zu Berlin and the Humboldt Forum Foundation in connection with or as a result of the photography and filming work carried out by the applicant and the persons acting with his/her knowledge. Permission may be subject to the presentation of appropriate insurance.
- 7. It should be noted that the permission for photography and filming is granted exclusively on the basis of householder's rights.

The applicant is responsible for:

a. obtaining and retaining the consent of photographed or filmed persons.



b. observing the rights of third parties to the photographed or filmed objects, such as, in particular, copyrights, related rights and other rights, and obtaining and retaining the necessary permissions.

It is expressly noted that no permissions relating to such rights are granted in the present case.

Should the Humboldt-Universität zu Berlin or the Humboldt Forum Foundation face claims from third parties in this regard, the applicant shall indemnify and hold harmless the Humboldt-Universität zu Berlin or the Humboldt Forum Foundation in full.

- 8. Any contractual or non-contractual liability on the part of the Humboldt-Universität zu Berlin or the Humboldt Forum Foundation, their legal representatives or vicarious agents is excluded. This exclusion of liability shall only not apply in the event of obligations to pay compensation under the Product Liability Act (Produkthaftungsgesetz) as well as in the event of damages resulting from death or injury to body or health that are due to an intentional or negligent breach of duty on the part of the contractual partners, their legal representatives or vicarious agents, in the event of other damages resulting from an intentional or grossly negligent breach of duty on the part of the contractual partners, their legal representatives or vicarious agents, and in the event of other damages resulting from a slightly negligent breach of material contractual obligations (socalled cardinal obligations), in which case the liability shall be limited to foreseeable damages and a sum of €5,000.
- 9. In the event of a considerable degree of effort, costs may be incurred and will be charged for the deployment of exhibition and event staff to supervise the photography and filming work in accordance with the hours worked (18.00 euros gross per hour). Depending on the effort involved, costs may also be charged for room rent.
